

With the expansion of Behavioral Health Services to telehealth, which began in the early days of the COVID–19 pandemic, VOAMASS can assist any Massachusetts resident with a behavioral health need, which in essence makes the organization a statewide service agency.



Q & A WITH **CHARLES GAGNON**

What aspects of the VOAMASS mission drew you to the agency?

Our mission's warmth and compassion. It leads us to help our neighbors most in need. It guides us to help the most complicated and challenging individuals in our community. It propels us to provide whole-person care – the mind, the body, the heart and the soul.

You are positioning VOAMASS as an integrated behavioral health organization. Why now and what role will VOAMASS play as a leader among providers?

Given the impact of COVID-19 and the glaring health inequities across the Commonwealth, the time is now to innovate, intentionally integrate our program model and engage specific populations whose needs are not fully addressed by the current public health system. Additionally, it is the right and just thing to do when facing social and economic injustice in our society. I believe the future of human services should center on evidencebased strategies that improve individual lives. Services will be provided through the lens of whole-person, integrated care interventions that address social determinants of health. The future of state and federal policy are moving in the direction of integrated care, and I want VOAMASS to be a pacesetter and serve as a thought leader to our partners in the community.

Our nation has experienced a lot since you became CEO of VOAMASS in 2019. From movements that addressed gender and racial inequities, to an unprecedented pandemic - what has all of this taught you about yourself and VOAMASS during this intensive period of challenge?

It has taught me to boost my thirst to learn. Boost my thirst to act. Boost my thirst to lead. And boost my thirst to provide solutions. It has also caused me to assess my own status in life, how it differs from others and what I can personally do to advance equity. I have a lot of work in front of me to become the person I strive to be!



As a mission-based leader, what is the single most important piece of advice you would give to new and emerging leaders?

You must feel the passion and urgency to lead with respect, dignity, and compassion. This is essential to improve the lives of people in need. All mission-based leaders should recall the words of Hillel the Elder: "If I am only for myself, what am I? If not now, when?"

Having now called Massachusetts your home for more than two decades, can we call this Minnesotan a New Englander yet?




